Purpose of the Committee: The Worship Committee advises the Minister on worship themes, elements, and rituals. Comprising lay-worship leaders (i.e. Worship Associates) and Congregants, this group meets monthly to discuss past services, upcoming services, and items pertinent to worship.

Achievements: During the 2019-2020 year, the Worship Committee is proud to have emphasized all family and multi-sensory worship, prior to COVID-19. Examples include activity tables throughout the sanctuary for individuals to engage with during the service. Additionally, a large portion of the achievements are post-COVID-19. Converting weekly worship to Zoom format has proved to be a considerable undertaking, but feedback indicates that the worship team is hitting the right notes on this front and providing impactful worships. Additionally, the mid-week gatherings have been an achievement - to provide impactful and sacred space on Wednesday evenings to extend worship throughout the week.

Lessons learned: While the majority of the lessons learned have been how to hold a meaningful virtual worship (e.g. power point, music, shorter sermon, etc) the worship committee notes that when we are able to incorporate the youth in services (e.g. YRUU leading a time for all ages for the mitten project) we have had particular success. Additionally, changing the seating in the sanctuary at the start of the year provided many challenges - and solutions - to the offering and lighting candles. The worship team had thoughtful discussions on these to make the seating structure work within the ritual of worship.

How does the committee work to further our mission and vision? The worship committee works to provide spiritual and ethical growth and a compassionate community through weekly worship that is welcoming, thoughtful, and timely.
